

NOTICE OF PUBLIC HEARING ON TAX INCREASE

This notice does not apply to a taxing unit that has a de minimis rate.

PROPOSED TAX RATE	\$0.07946362 per \$100
NO-NEW-REVENUE TAX RATE	\$0.07302685 per \$100
VOTER-APPROVAL TAX RATE	\$0.07946362 per \$100

The no-new-revenue tax rate is the tax rate for the 2023 tax year that will raise the same amount of property tax revenue for Reeves County Emergency Services District No. 1 from the same properties in both the 2022 tax year and the 2023 tax year.

The voter-approval rate is the highest tax rate that Reeves County Emergency Services District No. 1 may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that Reeves County Emergency Services District No. 1 is proposing to increase property taxes for the 2023 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 12, 2023 AT 5:30 PM AT the District's Administration Building, 2269 Ocotillo Drive, Pecos, Texas 79772.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, Reeves County Emergency Services District No. 1 is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Board of Commissioners of Reeves County Emergency Services District No. 1 at their offices or by attending the public hearing mentioned above.

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.
